Application is hereby made for the above show. A waiting list may be imposed. 6-Foot table option: 1st table \$150, 2nd table \$130, additional tables \$100. 8-Foot table option: 1st table \$175, 2nd table \$150, additional tables \$125. Each table rental includes one backup table, a power outlet, one (1) dealer chair for each name tag, and two (2) customer chairs. End Cap Option: 3 8-foot tables at the end of the row. Each table faces a different aisle. Includes a power outlet, only one (1) backup table, two (2) dealer chairs, and five (5) customer chairs for the end cap. Additional tables may be added to the end cap rental at the rate of \$125 per table. The Midlands Coin Club (MCC) reserves the right to substitute a larger table as deemed necessary. Such substitutions cannot be requested and will not result in any change in fee structure. 6-foot and 8-ft tables cannot be combined.

- Tables may not be transferred, sold, or given away.
- Tables may be shared with prior approval by the Bourse Chairman.
- MINIMUM DEPOSIT OF 50% OF THE TABLE FEES IS DUE WITH TABLE RESERVATION. Paid deposits guarantee tables, period. Tables can and will be sold until a deposit is received so pay your deposit early. Full payment is due 30 days before the show date. If you fail to show up or neglect to pay in full per arrangements made with the bourse chairman, monies paid are not refundable (special circumstances notwithstanding and at the discretion of the bourse chairman).
- Every dealer and their employees must be a Midlands Coin Club member. A membership application is provided with this bourse application package and may be reproduced as necessary.
- Each dealer must have a separate bourse application on file even when sharing tables.

In making application I agree to the following:

- 1. All applicants must be 21 years of age or older.
- 2. This contract, once signed by both parties, is NOT TRANSFERABLE. A penalty imposed is forfeiture of bourse space. NO REFUNDS will be given or cancellations accepted after thirty (30) days prior to the show start date.
- 3. If a dealer is not expected to show up on the first day of the show, the Bourse Chairman must be notified at least 7 days before the first day of the show. Any dealer not arriving by the first day of the show and who has not notified the Bourse Chairman will forfeit his table and deposit.
- 4. Applicants allowing unregistered dealers/employees behind their table(s), or offering spurious, counterfeit, or altered material, or conducting themselves in an unprofessional manner may be removed from the show with the bourse fee totally forfeited. Depending on the offense, the Midlands Coin Club board may impose a ban from the club and/or a ban from future shows.
- 5. Applicants will be responsible for transactions that take place at their bourse space during the show and for collecting and remitting applicable taxes to the proper authorities
- 6. The applicant will furnish showcases, table lights, extension cords, display materials, and applicable licenses.
- 7. This application releases the Midlands Coin Club (MCC), The Medallion Conference Center, and all their officials, representatives, and members from any liability subsequent to or during the show. MCC, Bourse committee, officers or members of the MCC, or any sponsoring clubs, or The Medallion Conference Center will not be responsible for any loss, damage, theft or personal injury that may occur from any cause whatsoever prior to, during, or subsequent to the period covered by the contract. The applicant expressly releases the aforementioned parties and agrees to indemnify same against any and all claims for such loss, theft, damage or injury.

No life membership may be granted over the objection of any Board of Directors member. Child members – may assist the Regular (Parent) member behind the bourse table with any task(s) except the actual transaction where coins and payments change hands. Accepting payments and / or merchandize from the public for items for sale at the bourse tables or making payments or exchanging merchandize with the public for other merchandize must be totally handled by the regular or honorary or life member.
